

The Honorable Supreme Council of Moorish America Republic has served to direct its nationals the following.

DECREE

IN THE NAME OF ALLAH THE GREATEST AND MERCIFUL

"THE COUNCIL OF MOORISH AMERICA REPUBLIC DECREE:

NATIONALITY AND PROCLAMATION LAW

CHAPTER I GENERAL DISPOSITION

Article 1.- This Law is regulated by Article 6 of the Divine Constitution of Moorish Science Temple of America and Articles 12 and 14 of the Constitution of Moorish America Republic. Its provisions are generally observed by all Nationals and members. Its application corresponds to the Ministry of Foreign Affairs and interiors through the respective consulates of Moorish America Republic.

Article 2º.- For the purposes of this Law, it shall be understood as:

- I. **Consulate:** Consulate post designated by Moorish America Republic, for assistance and assistance in the proclamation of Aboriginal Moorish American nationality, as well as in charge of defending the rights and interests of nationals.
- II. **General File of Facts:** Dependency in charge of giving publicity and legality to the acts or facts made before an official of Moorish America Republic or its consulates.
- III. **Aboriginal Proclamations:** Legal Instrument approved by the corresponding consulate, for registration in the Vital Records.
- IV. **Registrar of Nationals:** Official designated to APPROVE AND RECTIFY the proclamation and adhesion of the members as Moorish American Nationals, this position will be filled by the acting consul.
- V. **Vital Records:** Dependency of Moorish America Republic in charge of the protection and updating of Moorish American nationals.
- VI. **Secretary of the Archive of General Deeds:** In charge of registering and tracing the documents of the interposed requests, in the absence of official designation, this position will be in charge of the Ambassador General.
- VII. **Moroccan Empire:** Empire of the Aboriginal Lands composed of the Northwest and Southwest of the African Coasts, the Atlantic Islands and the Present American Continent.
- VIII. **Moorish America Republic:** Government and Aboriginal Nation of the North, Center, South America and the Adjacent Islands (Amexem), belonging to the Moroccan Empire.
- IX. **Moorish Science Temple of America:** Sovereign Theocratic Government and Corporate Political Body for the proclamation of the Moorish American Nationality and Adhesion to the Moroccan Empire and Moorish America Republic.
- X. **Moorish Consulate Post:** Consulates in charge of helping the Moorish American proclaim their true nationality and watch over their interests.
- XI. **Membership letter:** Document issued by the Moorish Consulate post where their attendance is accredited, name, advance of knowledge, among others.

Article 3º.- They are probative documents of the Moorish American nationality.

- I. The Certificate of Affiliation issued in accordance with the provisions of the written and customary laws of Moorish America Republic.

- II. The Aboriginal Card issued by Moorish America Republic through its consulates and issued in accordance with the provisions of the applicable provisions.
- III. The Aboriginal proclamation carried out by the Registrar of Nationals and registered in the vital records through the General Archive of Facts and registered by the Secretary of the General Archive of Acts.
- IV. In the absence of the evidentiary documents mentioned in the preceding sections, the Moorish American nationality may be accredited, with the corresponding affirmation and verification of the awareness of the aboriginal identity before the designated authority.

CHAPTER II

OF MEMBERSHIP AND NATIONALITY BY BIRTH OR BY PROCLAMATION AND ADOPTION.

Article 4.- They are Moorish American by proclamation and adoption, those who carry out before the corresponding consulate their aboriginal proclamation of nationality and free name.

- I. If his conscience is well founded and leaves the bonds of affection, as stipulated by the Holy Prophet Noble Drew Ali, he will become a national by birth.
- II. The Proclamation and adoption will be carried out by the registrar of nationals within any of the consulates officially designated by Moorish America Republic, with the assistance of the secretary of the General Archive of Facts.
- III. All proclamations will be registered both in the National Register of Facts and in the Vital Records Office, immediately, and will be made known as settled, by issuing the corresponding documentation.
- IV. The titles of Nobility referred to in article 6 of the Constitution will be adhered to the name of the slave family at the time of its proclamation.

Article 5.- They are Moorish American by birth, regardless of what is stipulated in the preceding article, fraction I, those who are children of a father or mother of Moorish American nationality and are accredited with any of the probative documents mentioned in article 2.

If a human being, male or female, is born by the union of two nationals, Moorish American, free, the son will have the title of nobility directly, without the need to interpose the name of the slave family, since this would be free from birth.

Article 6º.- All those who are active members of MOORISH SCIENCE TEMPLE OF AMERICA are eligible for the Moorish American nationality.

Article 7.- The members of the Moorish Science Temple of America, those who attend the meetings and events of the Moorish Science Temple of America programmed by the Consulates and have their membership card are considered.

Article 8.- To be a member of Moorish Science Temple of America, the interested party must.

- I. Attend at least nine scheduled meetings,
- II. Conduct a general knowledge test, and
- III. Be accepted by the council.

CHAPTER III

OF THE LOSS OF NATIONALITY MOORISH AMERICAN

American Republic in accord with title 22 section 611 (I)

Article 9º.- The Moorish American nationality will be lost only at the moment of losing consciousness of its aboriginal identity, except for itself.

- I. The national loses or is lacking in his mental faculties.
- II. The national is in a state of interdiction.
- III. The national loses his conscience due to assimilation by any government or authority present in our aboriginal lands.

Article 10.- If any national were to fall into disgrace and were in any of the cases mentioned in the preceding article. And if any individual or authority tries to assimilate or undermine Aboriginal identity and / or nationality, the corresponding consulate will have to intervene to validate the rights and claim the IUS IN RE from Moorish America Republic.

CHAPTER IV

OF THE FACULTIES OF THE CONSULATES AND THE RIGHT OF PROTECTION

Article 11 .- To invoke the protection mentioned in Article 10, the interested party (guardian) in charge will have to direct an official letter to the corresponding consulate to be attended immediately.

- I. This will not be necessary if the affected party does not have a guardian and the consul is aware of an event.
- II. The consul in his capacity as plenipotentiary may carry out any consular representation before any government or authority present in our lands.
- III. To do the above, if it is not urgent, you will have to consult with the council to receive the corresponding approval and support.
- IV. The council, once the request has been received informally, will have a maximum period of 48 hours to respond to the matter.
- V. If the intervention is urgent, the request and approval will be made verbally, which will be transcribed informally as soon as possible.

Article 12.- Powers of the consulates and the authorities of the Moroccan Empire and Moorish America Republic.

- I. Conduct the investigations corresponding to the History of all the members of Moorish Science Temple of America.
- II. Revoke membership at the discretion of members with a doubtful or unpleasant background.
- III. Revoke consular protection to members or nationals, based on an irrefutable fact of disobedience to natural law, the right of others, or any law of this Grand Nation.

Article 13º.- Without prejudice to the previous article, any member or national Moorish American may request consular assistance and protection, at any time and in any moment, as long as it is in reference to the aboriginal nationality and identity.

CHAPTER V

OF THE OBLIGATIONS OF THE NATIONALS AND MEMBERS

Article 14º.- They are obligations of the members and nationals.

- I. Go to scheduled events on time.
- II. Help financially with the expenses that are generated in the events.

- III. Obey the divine teachings of the Noble Prophet Drew Ali.
- IV. Keep the education and training received in the chambers of adherents in absolute secrecy.
- V. Support the other members and nationals, to form a unit that leads to the uprising of fallen humanity.
- VI. Obey and respect written and customary laws, as well as government authorities.
- VII. Protect your brothers and sisters before any circumstance and above any individual or authority present in our lands.
- VIII. Serve with humility, simplicity, joy, love, truth and justice in the positions conferred upon them to help the uprising of fallen humanity.
- IX. The others that the Council of Moorish America Republic considers appropriate.

TRANSITORIES

FIRST.- The present law will come into force immediately.

SECOND.- Publish in the Official Gazette electronically, immediately.
