The present appointment will take effect from the fourth day of August of the two thousand and seventeen, and can only be revoked by means of a written thirty days in advance.

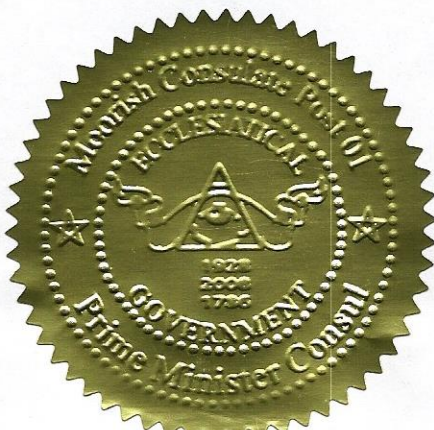
