Know all Corporate Governments presents on the aboriginal lands of North, Central, South America (Amexem) and Adjacent Islands by this present Moorish American Republic & Moorish Science Temple of America (Sovereign Theocratic Government) Appointed to Everardo Rodriguez-Bey for Grand Sheik Consul (Plenipotentiary), of Moorish Consulate Post 01 (Moorish Nation, Moorish Science Temple of America) located at coordinates 18°45'02.1"N 100°18'02.2"W, to protect all interest and goods, and defend the Rights of Aboriginal Government/Nationals of Moorish American Republic, and to ensure the property and all properties thereof that are not prejudiced and are in the disposition of use or enjoyment of any national Moorish American.

**WHEREAS,** by this present we corroborate the proclamation of Everardo Rodriguez-Bey, recorded on COOK COUNTY RECORDER OF DEEDS by the document number 1219429072, as a national of Moorish American Republic and in accord with our laws he take the right to occupy the post.

WHEREAS, The present appointment has made under the authority thrust into me and will take effect from the ninth day of July of the two thousand and fifteen, and can only be revoked by means of a written thirty days in advance.

Made in the land known as America (AMEXEM, AL MOROC, NORT WEST AMEXEM, MOROCCAN EMPIRE), in this year of our Lord two thousand and fifteen, and Moorish calendar one thousand four hundred and thirty five.

And the present seal is granted for all official documents of Moorish Consulate Post 01, any other is null.
